

Admission Arrangements for K1 Places in Nursery for the 2019-2020 School Year

Briefing session (K1) will be held on 08/10/2018 to 13/10/2018, also the distribution of printed 'Notification forms of interview' on the same

Parent submit the "reply slip of Interview Notification" to school before October

Interview will be held on 10/11/2018

School will notify parents of the application results before 21 December 2018

Parents will be required to confirm acceptance of a K1 place by completing the registration form during the stated registration dates (10-1-2019 to 12-1-2019)

School will notify parents of the 'Enrollment Notification' by post before the end of June

- 1. For parents who submit the application form, please bring the \$40 registration fee and the below information:
 - Including filled application form, 1 photo ID's, copy of birth certificate, and copy of immunization card and return envelopes.
- 2. School will not hold the place if the parents give up the registration, no registration fee will be refunded.



Information on Admission to K1 class in 2019-2020

Collection of application Forms (No quota)

- 1. Download from school website
- 2. Obtain from school in person

Distribution Period

Whole year

Return of Application Forms (No set quota for the kindergarten)

- 1. Return method: Submit the application form in person, together with the documents required including: [One child's recent photos of passport-photo size, four envelopes with own address and stamps, photocopy of the child's birth certificate and immunization record]
- 2. Application fee: HK\$40 (to be collected on the interview day). The application fee is non-returnable whether the application is successful or not.

Applicants can either download or come to the school to get the application form. Parents must bring the following child's document and submit the application in person during office hours:

Date: From 14-1-2019 to 19-1-2019

Monday to Friday: 9:30 am to11:30 am; 2:00 pm to 4:00 pm

Saturday: 9:30 am to 11:00 am

Application for the "Registration Certificate for Kindergarten Admission"

- 1. Education Bureau (EDB) will implement the Free Quality Kindergarten Education policy starting from the 2019/20 school year to replace the existing "Pre-primary Education Voucher Scheme". Under the new Scheme, EDB will use the "Registration Certificate for Kindergarten Admission" as the document for registration.
- 2. Parents are required to submit an application for the "Registration Certificate for Kindergarten Admission" (hereafter referred as "RC") to EDB <u>from September to November 2018</u>. The "RC" will be open for applications in September 2018 and EDB will announce and upload the details of application onto EDB's website (http://edb.gov.hk/) in due course.

Admission Criteria

- 1. Agree with our education mission and purpose of association
- 2. Interview performance
- 3. Applicants' age is fulfil with school vacancy
- 4. The applicant with sibling(s) currently studying in the kindergarten will be given due priority consideration
- 5. The applicant from families in need will be given due priority consideration.

Remarks: As the number of school places is limited, please understand that not all applicants fulfilling the priority consideration will be guaranteed a school place.

Interview Arrangements

- 1. The kindergarten will arrange interview for all applicants.
- 2. Interviews will be conducted on 10/11/2018.
- 3. Group and individual interviews will be arranged.
- 4. Parents should accompany their child for the interview.

Announcement of Admission Results

We will inform parents of the K1 admission results before 21 st December 2018 by post.

Registration Arrangements

- 1. Successful applicants: Parents should complete the registration procedures for their child from 10th to 12th January 2019 ("Centralised Registration Dates") by submitting the original of the "RC" / "Kindergarten Admission Pass" (here after referred as "KAP") to the kindergarten and paying the registration fee.
- 2. Applicants on the waiting list: Parents should complete the registration procedures for their child according to the specified date set by the school. Parents are required to submit the original of the "RC" / "KAP" to the kindergarten and pay the registration fee.
- 3. Please be reminded that if parents cannot submit the "RC" / "KAP" during registration, the kindergarten may not be able to complete registration for their child. Hence, parents are required to submit application for the Registration Certificate to EDB within the specified period.
- 4. The registration fee for 2019/20 K1 place is HK\$1,570. Should parents decide to change school after registration, please notify the kindergarten in writing. The kindergarten will return the RC" / "KAP" but the registration fee will not be refunded. Upon obtaining the "RC" / "KAP", the kindergarten will no longer keep the school place for the child.
